

**EXECUTIVE ORDER  
OF THE PRESIDENT OF THE REPUBLIC OF ARMENIA**

**ON ESTABLISHING AN INTERAGENCY COMMISSION ON COMBATING DRUG ADDICTION  
AND ILLICIT TRAFFIC IN NARCOTIC DRUGS IN THE REPUBLIC OF ARMENIA**

Guided by Article 55(6) of the Constitution of the Republic of Armenia and based on the Executive Order of the President of the Republic of Armenia NK-162-N of 25 September 2009, *I hereby decide:*

1. To establish an Interagency Commission on Combating Drug Addiction and Illicit Traffic in Narcotic Drugs in the Republic of Armenia and to approve the composition thereof according to Annex 1.
2. To approve the rules of procedure of the Interagency Commission on Combating Drug Addiction and Illicit Traffic in Narcotic Drugs in the Republic of Armenia according to Annex 2.
3. To the Chairperson of the Interagency Commission on Combating Drug Addiction and Illicit Traffic in Narcotic Drugs in the Republic of Armenia; to submit information — on semi-annual basis — to the President of the Republic of Armenia about implementation of the measures envisaged by the National Programme on Combating Drug Addiction and Illicit Traffic in Narcotic Drugs in the Republic of Armenia.

**RULES OF PROCEDURE**

**OF THE INTERAGENCY COMMISSION ON COMBATING DRUG ADDICTION AND ILLICIT  
TRAFFIC IN NARCOTIC DRUGS IN THE REPUBLIC OF ARMENIA**

**I. GENERAL PROVISIONS**

1. The Interagency Commission on Combating Drug Addiction and Illicit Traffic in Narcotic Drugs in the Republic of Armenia (hereinafter referred to as “the Commission”) provided for in the National Programme on Combating Drug Addiction and Illicit Traffic in Narcotic Drugs in the Republic of Armenia in 2009-2012 (hereinafter referred to as “the Programme”) approved by point 1 of the Executive Order of the President of the Republic of Armenia NK-162-N of 25 September 2009 shall — for the purpose of implementing the activities provided for in the Programme — arrange the monitoring, summarise and process the outcomes, as well as the comments and recommendations obtained thereon.

2. The Commission shall carry out its activities in conformity with the Constitution, laws of the Republic of Armenia, decrees and executive orders of the President of the Republic of Armenia and these rules of procedure.

**II. TASKS AND ACTIVITIES OF THE COMMISSION**

3. The tasks of the Commission shall be the summarisation and evaluation of outcomes of implementing the activities provided for by the Programme, as well as preparation of references of analytical nature.

4. The Commission shall, for the purpose of performing its tasks, arrange the monitoring of implementation of the activities provided for by the Programme in accordance with the legislation of the Republic of Armenia.

### **III. COMPOSITION OF THE COMMISSION AND THE ARRANGEMENT OF ITS ACTIVITIES**

5. The Chairperson of the Commission shall be the Secretary of the National Security Council.
6. The Chairperson of the Commission shall:
  - (1) manage the activities of the Commission;
  - (2) arrange discussions with the participation of representatives of state authorities of the Republic of Armenia and of public unions;
  - (3) summarise the recommendations and comments obtained from state authorities of the Republic of Armenia and public unions on performance of the activities provided for by the Programme;
  - (4) designate the venue, date for the sitting of the Commission and approve the agenda;
  - (5) convene the sittings of the Commission, represent the Commission before other authorities and organisations.
7. The Commission shall carry out its activities based on a work plan which is approved by the Chairperson of the Commission.
8. The Commission shall convene sittings which are summoned on an ad-hoc basis but not less than once in each quarter.
9. The Chairperson of the Commission shall chair the sittings of the Commission.
10. The Commission can set up working groups, invite experts, including from other state authorities, other states, international and other organisations.
11. The Chairperson and the Secretary of the Commission shall sign the minutes of the sittings of the Commission.
12. The sittings of the Commission shall have a quorum if attended by at least two thirds of the members of the Commission.
13. The decisions of the Commission shall be adopted by an open vote with the simple majority of votes of the members present in the sitting. Where any of the members have other opinion on the decision of the Commission, it shall be attached in writing to the minutes of the Commission sitting; it becomes the integral part thereof.
